Studying at **Junior College**

STUDY PROGRAMMES ON OFFER

JC offers a number of educational programmes which are specifically designed to suit different student learning requirements, to ensure that every student is given the opportunity to continue their education. These include programmes intended for students who have just completed compulsory education, 18+ students, as well as for others who would like to restart their education at this level.

At Junior College, you can:

- join a study programme for the first time •
- restart first year ٠
- start second year •
- ٠ restart second year
- enrol as 18+ students •
- enrol as adult learners .
- follow a one-year programme •
- follow an evening programme

Students following a study programme which is longer than one academic year, are automatically promoted to the second year after successfully completing their first year.

GENERAL ENTRY REQUIREMENTS FOR JUNIOR COLLEGE FOR ACADEMIC YEAR 2023/24

It is highly recommended that as a prospective student, whether in possession of all the entry requirements or not, you apply during the first admission period in July 2023. Students not in possession of all the entry requirements are encouraged to use the September supplementary session to obtain all the entry requirements.

The following entry requirements for admission to Junior College (JC) apply to all students under 18 years of age:

1. any six (6) passes in the Secondary Education Certificate (SEC) Examination at Grade 5 or better, or when applicable, the equivalent, which must include any one of the core subjects (English Language, Maltese, Mathematics).

- 2. Prospective applicants who are not in possession of any one of these core subjects, are expected to attend preparatory classes, to assist them to sit for the respective SEC examinations, as these are required for entry to UM.
- 3. In cases where an applicant does not hold SEC gualifications, but has gualifications from other Boards, the applicant may still be admitted following a favourable recommendation of the Admissions Board.
- 4. Applicants whose qualifications fall short of those required due to a significant disability, including individuals within the Autism Spectrum and with specific learning difficulties, may make a request to the Admissions Board who, on the advice of the Access Disability Support Committee (ADSC), will consider each application on its own merit.
- 5. International students, or applicants not in possession of SEC gualifications are to contact the Student Services Office by sending an email.

GENERAL CONDITIONS

- 1. As a registered student, you are expected to follow JC Regulations and Guidelines as published on the JC website (jc.um.edu.mt/journey/admissionsadvice/proceduresduties)
- 2. As a student at the College, you will be prepared for the MATSEC examinations only at the end of your study programme (SP).
- 3. It is your responsibility to ensure that your choice of subjects to obtain the Matriculation certificate is in line with MATSEC regulations (um.edu.mt/matsec/regulations). The same applies if, at any time, a change of subjects is requested.
- 4. All prospective students, who are under 18 years of age, must have at least one parent/guardian residing in Malta.
- 5. You may only register for **one** of the study programmes the College offers, at a time, and cannot be registered at JC concurrently with another institution.
- 6. If you wish to pursue your studies at the University of Malta (UM), you should be aware of the general entry requirements and special course requirements before you enrol at JC. It is your responsibility to ensure that the choice of subjects for entry to undergraduate courses conforms with such requirements. Further information can be obtained at um.edu.mt/sas/scr
- 7. It is **strongly advisable** that prospective students, including adult learners, contact the Student Advisory Services (um.edu.mt/sas) to assist them with the requirements for the course they intend to choose.
- 8. You are expected to commit yourself to your programme of studies and attend all sessions in your timetable.

EXEMPTION FROM MALTESE LANGUAGE AS AN ENTRY REQUIREMENT TO UNIVERSITY OF MALTA

"12 (5) Further to the requirement of Maltese at Secondary Education Certificate level, the Admissions Board may, in special circumstances and subject to the conditions set out hereunder, allow an applicant to offer another subject instead of Maltese, as follows:

(a) a Maltese applicant who, for reasons of residence or education abroad over a significant period during the previous four vears, has not received adeauate teaching in Maltese, may be allowed to offer another language instead of Maltese, or, until September 2018, any other subject.

(b) a non-Maltese applicant may be allowed to offer instead of Maltese, another language as approved by the Admissions Board, provided that, as from September 2018 such other language cannot be English and applicants whose mother tongue is English shall be required to offer a language other than English instead of Maltese.

(6) Notwithstanding that provided in paragraph (5) of this regulation, where Course regulations or by e-laws specify Maltese as a special Course requirement, the required pass in Maltese must be obtained at the level and grade as stipulated in the respective Course regulations or bye-laws."

As of **October 2025**, the above will be substituted with the following:

"13 (1) As from October 2025, for admittance to the Junior College, and as from October 2027, for admittance to the University undergraduate courses, further to the requirement of Maltese at Secondary Education Certificate level, as specified in regulations 10 and 12 of these regulations, the Admissions Board may, in special circumstances and subject to the conditions set out hereunder, allow an applicant to offer another language instead of Maltese, as follows:

(a) a Maltese applicant who has lived and studied abroad for a significant period during the previous four years, and has not received adequate teaching in Maltese.

(b) a Non-Maltese applicant, who pursued at least four years of compulsory secondary level schooling in Malta, may present a pass at Grade 5 or better in II-Malti bhala Lingwa Barranija (SEC) for admission.

(c) a Non-Maltese applicant, who pursued less than four years of compulsory secondary level schooling in Malta, may present either a pass at Grade 5 or better in II-Malti bhala Lingwa Barranija (SEC) or in another language at SEC level at Grade 5 or better or at a comparable level.

(2) Notwithstanding the provided in paragraph (1) of this regulation, where for admittance to the University Undergraduate courses, course regulations or bye-laws specify Maltese as a special Course requirement, the required pass in Maltese must be obtained at the level and grade as stipulated in the respective Course regulations or bye-laws."

Duration	Two (2) years on a full-time basis
	This programme is in adherence to MATSEC syllabi and regulations.
Outline	Students must choose six (6) subjects, three (3) at AM level, two (2) subjects at Intermediate Matriculation (IM) level and Systems of Knowledge (as a compulsory subject).

STUDY PROGRAMME FOR STUDENT ATHLETES

Objective	Offers student athletes the possibility of obtaining their MATSEC Certification whilst maintaining their training programmes with a National Sport Federation/Association (NSFA) which is officially recognised by the Malta Olympic Committee and/or with the National Sports School (NSS).
	Option A: SP aimed for national team athletes.
Programme Streams	Option B: aimed for students who completed their compulsory education at the NSS and for national team athletes who would like to choose this option. This choice is not offered in all sport disciplines.
	General entry requirements for Junior College apply (see page 7).
Entry requirements	Student athletes following Option A must present a written endorsement from the respective NSFA that they form part of a national squad/team or potentially can be part of one within one year. This endorsement must be presented by 18 August , and must be renewed at the beginning of each academic year.
	Student athletes following Option B must present either a written endorsement from the NSS that they have the potential to continue training with the said school, or from the relevant NSFA (as in previous paragraph).
Duration	Two (2) years on a full-time basis
	Matriculation Course (Standard) outline applies.
	Student athletes following Option A will have their timetables scheduled from Monday to Friday between 09:00 and 15:00. This is subject to availability.
Outline	Student athletes following Option B will have their timetables scheduled between 10:00 and 17:00 on Tuesday, Wednesday and Thursday, and between 08:00 and 17:00 on Monday and Friday. Training will be provided by NSS in conjunction with the respective NSFA between 07:45 and 09:30 on the days indicated above.
	Student athletes are provided with Special Sports Exemptions allowing them to participate in training, events and/or competitions following a request from the respective NSFA.
	Student athletes can bring their personal coach/trainer to JC provided they are officially recognised as such by the respective NSFA.

While the JC is responsible for the academic aspect of the programme, the respective NSFA or NSS is responsible for the training provided in the relevant disciplines.

STUDY PROGRAMME FOR MEDICINE AND SCIENCE ORIENTED STUDENTS

	Aimed for science students who need to upgrade their MATSEC results in order to follow a course in Medicine and Surgery, Dentistry, Health Care or Science courses at UM.
Objective	 The Study Programme is specifically aimed at helping such students improve their: grades at Advanced Matriculation (AM) level in Biology and/or Chemistry, as well as of subjects taken at Intermediate Matriculation (IM), scientific skills and analytical thought processes, preparation to join one of the said courses.
	General entry requirements for Junior College apply (see page 7).
Entry	Students are required to produce an official MATSEC result and/or a past MATSEC certificate to attest they already sat for Biology and/or Chemistry AM examinations.
requirements	Students, who did not sit for MATSEC examinations and wish to join the programme, must provide evidence that they have followed a full course in Biology and/or Chemistry in a recognised institution at AM level.
Duration	One (1) year on a full-time basis
	The course in AM Biology and/or Chemistry will have a different structure from the one offered to students enrolled in the regular two-year course.
	The material covered in this course presumes a level of competence in Biology and/or Chemistry equivalent to that expected at AM level.
Outline	Each AM subject is scheduled to have eight (8) sessions per week, which include lectures, tutorials, studying skills and practical sessions.
	The weekly practical sessions based on the entire syllabus aim to improve the skills and practical examination performance. These are intended to complement any practical coursework previously presented to MATSEC.

General Conditions apply (see page 8).

Students following this course may study up to two (2) subjects at AM level which must include Biology and/or Chemistry, as well as a maximum of three (3) IM level subjects of their choice and Systems of Knowledge (SOK).

Conditions For the purpose of the AM Biology MATSEC examination, any coursework covered in another institution must be appropriately certified at source.

The programme for the IM level subjects and SOK assumes that the student is in possession of the body of knowledge that is normally acquired during the first-year programme of studies at JC, as students will join second-year JC students taking the same subjects.

Students are expected to attend all timetabled sessions.

STUDY PROGRAMME FOR 18+ STUDENTS

Objective	Offered to prospective students who are at least 18 years of age at the time of application (henceforth referred to as 18+ students) with the possibility of studying one or more subjects at Advanced level (AM) and/or Intermediate level (IM) according to their needs.
	Prospective 18+ students enrolling in this programme must be in possession of three (3) passes in the Secondary Education Certificate (SEC) Examination or when applicable, their equivalent at Grade 5 or better. The subjects must include: English Language, Maltese and Mathematics.
Entry requirements	Applicants who are 23 years old or will turn 23 by the time they finish the course (henceforth referred to adult learners) are exempted from presenting the entry requirements above. However, a SEC level pass in English or a Secure English Language Test (SELT) result is highly recommended.
Duration	Two (2) years on a full-time basis
	Applicants can choose any one of the options offered: Option A: Matriculation Course (Standard) aimed at obtaining the Matriculation Certificate in adherence to MATSEC regulations. Students are therefore allowed to choose a maximum of six (6) subjects, two (2) at AM level, three (3) subjects at IM level and Systems of Knowledge. Matriculation Course (Standard) conditions apply.
Outline	Option B: Matriculation Course (Extra) aimed at obtaining the Matriculation Certificate in adherence to MATSEC regulations. Students are therefore allowed to choose a maximum of six (6) subjects, three (3) at AM level, two (2) subjects at IM level and Systems of Knowledge. Matriculation Course (Standard) conditions apply. Option C: My Choice Study Programme allows learners to take up to a maximum of four (4)
	subjects of their choice.

- You are strongly advised to consult the relevant MATSEC syllabus available at um.edu.mt/matsec to know more about a particular subject.
- For the Matriculation Certificate, you are required to study Systems of Knowledge, which is a compulsory subject, together with two subjects at Advanced level and three subjects at Intermediate level.
- The choice of subjects should include **at least one subject** from each of Groups 1, 2 and 3. The other two subjects may be chosen from any of the four groups (refer to table on page 21).
- You are advised to identify your areas of strength and interest and to choose the subjects that match these strengths and interests.
- Should you intend to continue studying at a higher level, you are to ensure that your choice of subjects matches the requirements.
- Some UM courses may require specific subjects as entry requirements, but there are University courses which **do not** have special course requirements. The full list of courses, including those having special course requirements, is available at **um.edu.mt/sas/scr**
- Whilst every effort will be made to ensure that prospective students can choose any combination of subjects, the JC reserves the right **not** to offer a particular subject if the number of applicants does not justify it or if logistics and timetable arrangements do not permit it.
- Students who study a combination of subjects which do not conform with regulations of the Matriculation certificate and UM entry requirements, cannot hold the JC responsible for their choice and level of subjects in view of their ineligibility to enrol with UM.

HELPING YOU TO CHOOSE

At JC you can study any of the subjects offered by MATSEC. In the case of subjects which have a corresponding SEC syllabus/examination, lecturers will assume that in choosing the subject, you have a pass in the subject at SEC level. When making your choice of subjects, you should take this into account in order to follow the study programme of your choice and stand to benefit from it. For those subjects which are offered at MATSEC level, but are not offered at SEC level, this is taken into account during teaching.

Before choosing your subjects, you are strongly advised to read information about individual subjects, available at jc.um.edu.mt/subjects/all

The College offers career guidance services to prospective students who require further clarification about their choice of subjects and study programmes. Student Advisors can provide further details about courses offered at UM, according to the subjects being considered. If you would like to avail yourself of this service, you are to book a guidance appointment via **jc.um.edu.mt/services/wellbeingservices/studentadvisoryservices**

Career guidance sessions are held either at JC or online via Zoom platform.

It is recommended that your parents/guardians attend the sessions with you.

GLOSSARY OF TERMS

While reading about the subjects online (ic.um.edu.mt/subjects/all), you will come across a number of terms which we invite you to be familiar with as they are beneficial to your studies:

When a grade at SEC level is recommended, it means that while it is not compulsory for you to have that grade, it is still ideal that you do.

A pass in a subject means obtaining a Grade 5 or better at SEC level, or the equivalent.

A **session** is a scheduled time slot in your timetable, such as a lecture, tutorial, seminar etc.

A lecture takes place with a whole group of students, and is intended to present information on a topic or a particular subject.

A seminar takes place in smaller groups, where assigned readings are discussed, questions can be raised and debates can be conducted.

A tutorial takes place in a very small group, in which the tutor gives you individual attention in assigned work, and you will be able to ask questions.

A practical session is a hands-on session held in a laboratory, art room or other specialised rooms, usually spanning over two hours.

A personal contact hour takes place when a lecturer meets you individually, or in very small groups, to guide and help you in the course of your studies. Ideally, you should ask for an appointment with your lecturers for a contact hour.

MATRICULATION EXAMINATION REGULATIONS

HOW TO APPLY

Applications for all study programmes can be made online at **jc.um.edu.mt/apply**. When you apply, you will receive an automated email reply as proof of receipt of your application.

Main applications will be accepted online from **24 July** to **10 August until 14:00** against a fee of \notin 23.30.

Late applications will be accepted online from 17 August to 25 August until 14:00 against a fee of €46.60.

Very late applications will be accepted online from 4 September to 20 October until 14:00 against a fee of €116.50.

Late and very late applications are not applicable to all study programmes. Applicants are to refer to the relevant programme descriptions.

You will **only** be admitted to the College during the admission dates indicated. It is important to note that the College has a strict policy regarding stipulated deadlines.

Junior College students who wish to restart the first or second year are to visit the College website at **jc.um.edu.mt** for more information.

An application fee is to be paid when applying and is non-refundable.





ON BEING ACCEPTED AS A JUNIOR COLLEGE STUDENT

Once your application has been evaluated, you will receive a letter of acceptance. As confirmation that you can start attending the College as a full-time student, you will be requested to pay €24 as Caution Money by credit card, before being registered as a regular student. By paying the Caution Money, you will be confirming your intention of attending Junior College. Once this stage is completed, you will be considered as a registered student.

If you do not pay the Caution Money within the stipulated time frame, you will automatically be considered to have "withdrawn" your application. Should you wish to reactivate your application, you would be required to pay the difference in application rate and relevant late application fee.

Applicants who are accepted as College students, but do not attend sessions regularly by the end of October, will automatically be considered to have withdrawn.

CAUTION MONEY

The Caution Money is intended to cover all or part of the total cost in the case that a student causes any damage or loss to equipment or property intentionally or accidentally, or if a student fails to return the student card at the end of the study programme or upon withdrawal.

The Caution Money will be refunded after you complete the **full** study programme at the College. However, it will be forfeited in case of the above circumstances. You will not be allowed to continue with your study programme if the full payment is not settled.

TIMETABLES

The Student Services Office will inform you by email once your timetable is available. You are to check the departmental webpages on the JC website to access your timetable. Should you have any clashes in the timetable, have six (6) consecutive sessions, or have any difficulty with your timetable, you are to immediately contact the Office of the Principal at **principal.jc@um.edu.mt** by not later than the last Friday of October.

REQUEST FOR CHANGE OF SUBJECT/S

It is possible for you to request a change of subject by the last Friday of October. Approval is not automatic but subject to administrative constraints, and, in the case of second-year students, the endorsement of the respective Subject Coordinator.

After this date, you may still submit a request for consideration for a change of subjects, by **not** later than the last Friday of November.

It is your responsibility to ensure that the changes requested fulfil the requirements of the MATSEC Certificate.

Students requesting a change of subject/s, are expected to make up for and take full responsibility for the subject matter/ projects/practicals and other educational experiences covered at Junior College during the first year or since the start of the academic year. You are to fill in the 'Change of Subjects Form' which is available at

ic.um.edu.mt/services/studentservicesoffice/requestforchangeofsubjects

Requests are to be submitted at the SSO. An administration fee of \notin 12.00 is applicable.

It is assumed that when a request for a change of subject is made, you have **not** already obtained a pass in the subject being changed.

PREPARATORY CLASSES

In accordance with the new entry requirements to JC, students who are not in possession of any 2 of the core subjects (English, Maltese, Mathematics) need to attend preparatory classes to follow a mentored study plan.

Such students will be informed individually when these sessions will be held.

REQUEST TO BE EXEMPTED FROM STUDYING SUBJECTS

Students, who are in possession of a pass in any subject/s at MATSEC level, are eligible to be exempted from studying the subject/s during their time at the College. Students are to fill in the 'Request to be exempted from Studying Subject/s' form which is available at **um.edu.mt/I/ZmPAH**. The form must be presented at the SSO, together with the original result slip/ certificate and its photocopy. Requests may be accepted throughout the year. An administration fee of €12.00 is applicable.

Students cannot request to take another subject instead.

ACCESS ARRANGEMENTS

The Junior College strives to support all students, especially those with a disability, or learning difficulty, or who require special arrangements.

Students with a chronic medical condition, a disability, or require special arrangements, are strongly advised to inform the College administration in writing, at the beginning of the year or as soon as the case arises. In such circumstances, a certificate from a specialist/consultant is required. This information will be treated in the strictest confidence.

The College administration liaises with the ACCESS-Disability Support Unit (ADSU) of the University of Malta to ensure that students avail themselves of all the appropriate and permitted support.

Access arrangements are made to enable students with disability to start, follow and complete a programme of study successfully. Access arrangements may include a time extension for programme completion. Some students cannot, or prefer not to follow a programme in the same time frame as their peers but may require a longer period of time.

Note: Students who require Access arrangements during MATSEC examinations are to make their request at the time of application for said examinations.

STUDENTS WHO ARE STILL MINORS

Students who are still legally under the age of 18, need to provide the College with the details of their legal guardian/s. The College may request evidence of this should the need arise to be able to communicate officially with the guardian/s of minors.

NEXT OF KIN

You are to give a contact number of one or two persons considered as next of kin. Next of kin include, but are not limited to, legal guardian/s. This information will be used to notify next of kin in case of an emergency.

STUDENTS' SAFEGUARDS

"11 (4) Where the Admissions Board has reason to believe that the presence of an applicant within the University community could present a clear and present danger to the wellbeing and safety of students and staff, or a significant risk that their safety be imperilled, or that activities on campus be disrupted, the Board shall on the basis of available evidence have the option to refuse admission, or to grant admission subject to appropriate safeguards which shall be decided upon on an ad hoc basis, or to delay admission until expert advice is obtained. For the avoidance of doubt, evidence could also take the form of expert advice documented in a sworn affidavit."

RESTARTING A PROGRAMME AT JUNIOR COLLEGE

College students who do not qualify to proceed with their studies from their first to their second year, may restart the study programme they were following, or start a new programme. Such students are required to fill in the '**Confirmation to Restart**' form online. Instructions related to this application will be sent later with the '**End-of-Year Academic Report**'.

The students' general performance and attendance during the previous year/s will be taken into consideration at application stage. Students may not be allowed to restart a year or a new programme, if it is felt that, based on their track record and qualifications, it would not be beneficial to them.

Applicants who attended the Junior College the previous year and would like to restart their study programme, are exempt from paying the relevant registration fee.

SUSPENSION OF STUDIES

Students, who need to suspend their studies for a valid extraordinary reason, are given the opportunity to restart their year of studies the following year as if they are applying for the first time.

Students, who would like to suspend their studies, are to present their requests for a suspension of studies to the SSO. Such requests are to be endorsed by appropriate documentation signed by a relevant professional.

WITHDRAWAL FROM STUDY PROGRAMME

Students, who need to withdraw from their study programme, are to download the **Withdrawal Request Form** from the Junior College website (**jc.um.edu.mt/students/forms**). The form should be duly filled in, signed by both the student as well as their parent/guardian and presented to the SSO.

The Student Wellbeing and Support Committee (SWSC) shall call the student to assess and evaluate the request. The student is normally expected to continue attending sessions until the SWSC considers the request and makes its recommendation. This will be communicated to the student within eight (8) working days.

If students decide to withdraw against the recommendation of the SWSC, then they will be asked to hand in the Junior College Student ID card to complete the process of withdrawal.

PERSONAL EDUCATIONAL RESOURCES

In order to make the best of the educational experience offered, students are encouraged to invest in the following:

Books:	these can be in hard or soft copy, depending on the students' preference or availability. Students should consult their lecturers before buying any books included on the book list.
Computer hardware:	having a personal computer is a very useful tool at this level of learning. A camera, microphone, and access to printing and scanning facilities should also be available.
Other items:	depending on the nature and demands of the different subjects chosen, students may be required to get other resources.

Students who may have difficulty in acquiring such resources due to financial constraints are invited to approach a member of staff of the Wellbeing Services. All matters and correspondence will be kept confidential.

INTERNATIONAL STUDENTS

The Junior College has a growing community of international students enrolled in the different study programmes. The College firmly believes in creating a welcoming environment where every student can integrate with ease and feel included. This enriches the educational experience for all.

International students are to contact the Student Services Office in case of any difficulty.





Enrichment Programme



In line with its mission statement, the College offers a whole range of activities, programmes and initiatives, collectively referred to as the Enrichment Programme (EP), which is meant to develop and enrich you holistically. The EP complements your formal study programme, and participation is completely voluntary.

ADDITIONAL ADVANTAGES OF PARTICIPATING IN THE EP

- Successful participation will be officially recorded in the final Junior College Study Programme Report.
- Marks gained by participation will be used for the purpose of promotion to second year.
- Participation may be valid for the purpose of the Systems of Knowledge project following approval from your tutor.

EP Units on offer

The EP is composed of a variety of EP Units (EPUs). Even if not considered formal, the EP is planned and structured in a way to ensure that specific outcomes and criteria are attained. For this reason, only units approved by the Junior College Board are considered as part of the EP.

All units are carried out under the supervision of an EP Coordinator appointed by JC.

You may also choose to learn an additional language at Intermediate level. This option offers the same advantages of the EP. More information about the additional language option is available at **jc.um.edu.mt/study/programmes/additionallanguageoption**

In addition, more information about this programme can be sought during *Hello Freshers!*, which is held during the first week of October.

You are encouraged to participate in other activities and initiatives but these **are not** considered as part of the EP. (See page 62 [Annual Events] for such activities).

EARNING MARKS THROUGH THE EP

Each EPU has a description, which includes the maximum number of marks that may be obtained by participating for the purpose of promotion to second year.

The marks allocated are **not** automatically earned. You will need to take an active role and attend a minimum of 50% of the allocated time to start earning marks.

Five (5) marks may be gained for every ten (10) hours of participation in a specific EPU up to a maximum of thirty (30) marks over a year. These marks will be added to the total number of marks obtained from each subject you study, for the purpose of promotion.

WHEN ARE EPUS HELD?

There is no set time when all EPUs are offered, however EPU sessions are usually held at the College and during the day, very often on Wednesdays at 14:00. Some units may involve travelling abroad, visits or meetings that need to be held during other hours.

REGISTRATION FOR EPUS

You need to formally register in advance through the JC website, and you will be informed how and when to apply through eSIMS.

In certain cases, a registration fee or other costs may be involved to cover participation.

Additional Language Option

The aim of the additional language option is to allow JC students to acquire an additional language. This option is offered to all first-year students.

Students taking up this option will be automatically gaining the advantages of enrolling in the Enrichment Programme (EP), including the possibility of earning up to 30 marks which may be used for the purpose of promotion to second year.

This option is only offered if a minimum number of students enrol to study a specific language. Lectures are normally held on Wednesdays at 14:00. More information is available online at **jc.um.edu.mt/study/programmes/additionallanguageoption**

JC STUDENT ID CARD

- As a JC student, you need to show that you are registered at the College, so the College will provide means for this to happen. All students are provided with a JC Student ID card for free at the start of the study programme. This card remains the property of the College and you are to return it in good condition at the end of your study programme. Should you fail to return the card as indicated, you will forfeit your Caution Money.
- 2. You must be in possession of the JC Student ID card at all times, and present it to security officers and members of staff whenever it is requested. Scan your card and keep a copy on your devices for easy access.
- It is your responsibility to keep the card in good condition. Should you lose the card, you are to contact the SSO immediately. For security reasons, misplaced, lost, misused cards (e.g. cards found in possession of third parties to gain entry to JC), or cards that are damaged to an extent that the student cannot be identified, are to be replaced by the SSO. An administrative fee of €12.00 applies.

Workstations

IT Services manages a number of workstations found in the library that are available to you. These workstations offer the use of standard software packages, email, web browsing, printing and scanning facilities. Some workstations offer access to other specialised application software such as ACAD. Laser printing (colour or black and white) is available on a self-service basis using printing credits (which can be purchased online).

Library

This is achieved by having a well-organised and updated collection together with trained librarians who are able to help you. The Library strives to provide you with a welcoming environment where you are empowered to be independent and skilled researchers, problem solvers and ethical users of intellectual property.

All material available can be retrieved by using HyDi which is a one-stop search gateway to all Library resources.

Junior College Library also collaborates with numerous Departments to organise Subject Specific Library Tours. Small groups of students together with their lecturer are welcomed to the Library. Here the students are given information on how the Library is organised and the services it provides. Additionally, students are introduced to titles relating to their subject within the General Collection.

The College Library also provides exhibition spaces for students wishing to exhibit their art work both as individuals and as a group.

Laboratories and specialised rooms

The College prides itself in offering the best laboratory resources to students studying science subjects. All laboratories have either been or are in the process of being refurbished to offer an optimal learning environment.

Each science subject at Advanced level includes regular practical sessions per week to complement the theory and to prepare you for MATSEC practical examinations.

Classes are divided into small groups during practical sessions in order to ensure individual attention in a safe environment.

A number of specialised rooms are also available to enhance the teaching of particular subjects. These include the Home Economics Laboratory, a Theatre and Performance studio, a Music room, two Art studios, and two Graphical Communication rooms.

Lecture rooms are equipped with data projectors, monitors or interactive white boards.

This service is accessible to members of staff, students and the general public. Both centres run all year round, except on weekends and public holidays.




